Sub: Swachh Bharat Mission - 1st Anniversary of Launching of Swachh Bharat Mission - Instructions for OBSERVATION OF 1ST SATURDAY OF EVERY MONTH AS CLEANLINESS AND SANITATION DAY - issued.

In continuation of instructions issued in the reference 1st cited, the Director of Municipal Administration, the Managing Director, Swachh Andhra Corporation, all the District Collectors, all the Municipal Commissioners, the Commissioner, Rural Development are informed that Government have decided to observe 1ST SATURDAY OF EVERY MONTH AS CLEANLINESS AND SANITATION DAY .

2. The Director of Municipal Administration, the Managing Director, Swachh Andhra Corporation, all the District Collectors, all the Municipal Commissioners, the Commissioner, Rural Development are therefore requested to OBSERVE 1ST SATURDAY OF EVERY MONTH AS CLEANLINESS AND SANITATION DAY in the State and to take up the following programmes:

- 1) The in charge Minister, ZP Chairperson of the District at the District level, Hon'ble MPs, MLCs, MLAs at the Constituency level, Mayors and Chairpersons at ULB level, MPP's and ZPTC's at Mandal level, Janma Bhoomi Committees at Village level and all the Public Representatives shall actively participate in this programme. Respective Temple Trust Board Chairmans, Temple Trustees and Religious heads shall also participate at their respective locations.
- 2) The District Collector, all the District level Government Officials, Judicial Officials, all Public Sector Undertaking Employees, Freedom Fighters, Senior Citizens, Religious leaders, Sports Personalities, Doctors Associations, ASHA workers, Anganwadi workers, NCC Cadets, Boys Scouts, Girls Guides, Theater Associations, Media, Cultural Associations, NGO Organizations, Education and Health Organizations, Self Help Groups, Resident Welfare Associations, Business and Industrials Houses, etc. shall actively participate in this programme.

- 3) Inspections to newly constructed IHHTs and their usage by the beneficiaries shall be taken up and public shall be motivated to take up construction of IHHTs and make the city/town/village open defecation free.
- 4) Cleaning of all the Government and Public places shall be taken up. All the citizens need to be motivated to take up cleaning of their houses. All the public places like Bus stations, Railway stations, Hospitals, MeeSeva centers etc., shall be cleaned and inspected by the Public Representatives and Officials.
- 5) Cleaning of Roads and Drains shall be taken up in all the wards and desilting of major drains shall be taken up and to be inspected by Public Representatives and Officials.
- 6) Cleaning of Parks and Burial grounds shall be taken up and to be inspected by Public Representatives and Officials.
- 7) The Community Toilets and Public Toilets shall be inspected by Public Representatives and Officials, the maintenance of the Community and Public Toilets shall be assessed. The public and community shall be motivated to use the Community and Public toilets.
- 8) The Removal of Posters and Banners etc., shall be taken up and action against the defaulters shall be taken.
- 9) The achievements made during the previous month shall be informed to the public and the activities proposed for the current month shall also be informed to all the concerned.
- 10) Active public participation shall be ensured at all levels and the citizens are informed of the Swachh Bharat Mission and motivated to achieve the objectives of the Mission.
