In view of the above and after careful examination of the proposals
 submitted by the Municipal Commissioner, Ramachandrapuram Municipality,

administrative sanctions is hereby accorded for construction of 5 Public Toilets with 08 seats @ Rs.98,000/- for an amount of Rs.7.84 lakhs and 30 urinals @ Rs.32,000/- per urinal for an amount of Rs.9.60 lakhs together for an amount of Rs.17.44 lakhs in the above 5 locations.

The Municipal Commissioner, Ramachandrapuram Municipality is requested to take up the construction of Public Toilets as per the due procedure. The above sanctioned amount will be released only after completion of the above work, geo-tagging & up-dation of information in the website.

Further, the Municipal Commissioner, Ramachandrapuram Municipality is also requested to submit the UCs for already released funds from the Swachh Andhra Corporation, GoAP, Vijayawada to the Ramachandrapuram Municipality within 15 days with out fail. Any deviation in this regard will be viewed serious and matter will be reported to the Government.
