The Municipal Commissioner, Kadapa Municipal Corporation has requested to sanction
an amount of Rs.20.76 lakhs for construction of 2 Public Toilet in 2 locations with 14
seats @ Rs.98,000/- per seat for an amount of Rs.13.72 lakhs and 22 urinals @
Rs.32,000/- per urinal for an amount of Rs.7.04 lakhs.

ORDER::

In the circumstances reported above, Administrative sanction is hereby accorded for an
amount of Rs.20.76 lakhs for construction of 2 Public Toilet as mentioned in above
table with 14 seats @ Rs.98,000/- per seat for an amount of Rs.13.72 lakhs and 22
urinals @ Rs.32,000/- per urinal for an amount of Rs.7.04 lakhs from the available
Budget of Community Toilets/Public Toilets under SBM Funds.

The Municipal Commissioner, Kadapa Municipal Corporation is requested to follow the
due procedure in grounding the sanctioned Public Toilet with in the time frame and the
funds will be released after completion of the Geo-Tagging of Public Toilet and
uploading the same in the Swachh Andhra Corporation Web site. Any deviation in this
regard will be viewed serious and matter will be reported to the Government for

necessary action.

The Municipal Commissioner, Kadapa Municipal Corporation is also requested to send the Utilisation Certificates for the balance funds within one week without fail. The Government of India is pressing for submission of Utilisation Certificate from the State Government under the above Heads of Accounts.

The sanctioned amount is chargeable to the Head of Account 2217-80-191-06- 87-310-312 & 2217-80-191-12-87-310-312 of the Community/Public Toilets sanctioned by the Government of Andhra Pradesh and Swachh Bharath Mission funds.
