SAC has issued LOA to M/s Sanghamitra Research Training & Consultancy services vide 3rd cited above for establishing MSWM project under DBOT basis in Atmakuru ULB of Kurnool Dt. and instructed the ULB to arrange for the desired land to the agency. Due to non-availability of Government / ULB land in the surroundings of Atmakur, Collector, Kurnool District in the reference vide 1<sup>st</sup> cited above, has requested Principal Secretary, MA&UD basing on the proposal of Commissioner, Atmakur-K for purchasing of private land to an extent of 5.52 acres in Sy.No. 88/1 of Atmakur. Further, GoAP in the reference vide 2<sup>nd</sup> cited above, has accorded permission for purchase of the said land from available SWM funds.

**ORDER:**

Under the above circumstances, sanction is hereby accorded for an amount of Rs. 46.92 lakhs (Rupees Forty Six Lakhs Ninety Two Thousand only) for purchase of land to an extent of 5.52 acres in Sy.No. 88/1 of Atmakur-Kurnool ULB @Rs. 8.5 lakhs per acre. The Commissioner, Atmakur Nagara Panchayat is requested to purchase the said land immediately duly following the office procedures and instructions by District Collector, Kurnool, so as to start the project activities by the Concessionaire.
