Sub : SAC – Fund releases to the Nellore Municipal Corporation towards procurement of 183Nos. Push Carts to handle Municipal Solid Waste efficiently – Sanction orders issued.

In the reference 1st cited the Government permitted Swachha Andhra Corporation to release the amounts to the ULBs to procure the Push carts under SBM SWM funds to handle Municipal Solid Waste efficiently, where in to Nellore Municipal Corporation provided 60 Nos at an amount of Rs. 7.20 lakhs and the same was released to Nellore Municipal Corporation.

In the reference 2nd cited an amount of Rs.27.36 Lakhs was released to the Commissioner, Nellore Corporation towards procurement of 228 No. Push carts.

In the reference 3rd cited, the Commissioner, Nellore Municipal Corporation submitted that 496 number of Micro Packets were identified for the implementation of G.O.279 and requirement of Pushcarts is 546 (1 per micro packet + 10% reserve). SAC has released an amount of Rs.34.56 lakhs towards procurement of 288 Nos. Pushcarts and NMC completed the procurement. Including existing 75 Nos of Pushcarts 363 Nos. Pushcarts are available with NMC thus needing balance 183 Nos. Hence the Commissioner NMC requested to sanction the amount for procurement of 183 Nos. Pushcarts.

Hence to implement GO.279 in NMC , sanction may be accorded to an amount of Rs. 21.96 Lakhs towards procurement of 183 No. Pushcarts to NMC.

ORDER:

In view of the above, sanction is hereby accorded to an amount of Rs. 21,96,000 (Rupees Twenty One lakhs and Ninety Six Thousands only) to Nellore Municipal Corporation towards procurement of 183 Nos. Pushcart under SBM SWM funds to handle Municipal Solid Waste efficiently in the NMC.
