2. Sanction orders to respective ULBs for additional Pushcarts.

The Government vide reference 1st cited sanctioned an amount of Rs.780.00 Lakhs towards procurement of 6500 Nos. Pushcarts to the ULBs and the same was released to the ULBs. Mean while as per the requisitions from the Commissioners to implement GO Ms No.279 additional 2070 Nos. pushcarts were sanctioned to respective ULBs.

Total amount sanctioned towards procurement of 8570 pushcarts is Rs. 10,51,70,640. Amount released towards 8327 pushcarts so far is Rs. 10,17,29,760. The balance amount to be released towards 243 pushcarts is Rs. 34,40,880 to the 7 ULBs as bellow.
