ORDER::

In the circumstances reported above, administrative sanctions are hereby accorded for an amount of Rs.22.70 lakhs for construction of One Public Toilet in Government Degree College, Kadapa with 15 seats @ Rs.98,000/- per seat for an amount of Rs.14.97 lakhs and 25 urinals @ Rs.32,000/- per urinal for an amount of Rs.8.00 lakhs in total Rs 22.70 lakhs from the available Budget of Community Toilets/Public Toilets under SBM Funds.

The Municipal Commissioner, Kadapa Municipal Corporation is requested to follow the due procedure in grounding the sanctioned Public Toilets with in the time frame and the funds will be released after completion of the Geo-Tagging of Public Toilets and uploading the same in the Swachh Andhra Corporation Web site. Any deviation in this regard will be viewed serious and matter will be reported to the Government for necessary action.

The Municipal Commissioner, Kadapa Municipal Corporation is also requested to send the Utilisation Certificates for the funds already released to the ULB within one week without fail. The Government of India is pressing for submission of Utilisation Certificate for the released amount to the State Government under the above Heads of Accounts.

The sanctioned amount is chargeable to the Head of Account 2217-80-191-06-87-310-312 & 2217-80-191-12-87-310-312 of the Community/Public Toilets sanctioned by the Government of Andhra Pradesh and Swachh Bharath Mission funds.
