Attention is invited to the subject and reference cited.

Vide reference cited, the Registrar of High Court of Judicature has requested for construction of toilets for litigant public in all the court complexes of Andhra Pradesh.

Accordingly, vide reference 2nd cited, administrative sanction was accorded to the Municipal Commissioner, GVMC for construction of public toilets in District Court Complex in Visakhapatnam and vide reference 3rd cited, administrative sanction was accorded to the SE, RWS & S for construction of community sanitary complex in Court Complex, Gajuwaka, Visakhapatnam District.

In view of the above, it has come to the notice that the Gajuwaka area is falling in the jurisdiction of GVMC. Therefore, Administrative Sanction is hereby accorded for construction of One Public Toilet at Gajuwaka with 2 seats (1 for men + 1 for women) seats @ Rs.98,000/- per seat and 8 urinals (4 for men + 4 for women) @ Rs.32,000/- per urinal for an amount of Rs.4.52 lakhs in the below location considering under Urban area, duly cancelling the AS accorded for the above site considered earlier that in Rural area. The details are as follows:
