Sir/Madam,

In connection with the 'POSHAN' Abhiyaan, in a meeting held on 18.04.2018 in Ministry of Women and Child Development, it was noted that many Aanganwaadi Centres (AWCs) in urban areas do not have proper toilets/Urinal facilities.

2. It has been decided that Toilets in AWCs may be constructed under the Swachh Bharat Mission (Urban) from the Centrally allocated Budget to the States. Such Proposals may be forwarded by the State Governments after approval of State High Powered Committee (SHPC) to Ministry of Housing and Urban Affairs for consideration as per Swachh Bharat Mission (Urban) guidelines.

3. In pursuance of the above, all States/UTs are requested to use the allocated budget for ODF (IHHT, CT/PT, Urinal) under Swachh Bharat Mission-Urban (SBM-U) for construction of Toilets/Urinals in Aanganwaadi Centres situated within the jurisdiction of the Municipal Corporations in their States/UTs.
