Vide reference 3 cited, the Managing Director of Swachha Andhra Corporation has accorded administrative sanction to the Municipal Commissioners of Pitapuram and Ramachandrapuram ULBs for an amount of Rs.4.52 lakhs each with 2 seats and 8 urinals at court complex in respective ULBs and the Municipal Commissioners are requested to send the location details to the undersigned in order to release 50% of sanctioned amount.

Accordingly the Municipal Commissioners of Pitapuram and Ramachandrapuram ULBs have submitted the location details to this office and vide reference 4th & 5th cited, an amount of Rs.2.26 lakhs was released to the each ULB and requested the Municipal Commissioners to take up the construction with the released funds and the balance will be released after completion of work, geotagging & up-dation of information in website.

Vide reference 1st & 2nd cited, the Municipal Commissioners of Pitapurama and Ramachandrapuram ULBs has informed that the construction of pubic toilets at court complex were completed and requested to release an amount of Rs.1,98,301/- to contractor of Pitapuram and Rs.1,86,645/- to the contractor of Ramachandrapuram ULBs.

After, verification of the Swachha Andhra Corporation website, the Municipal Commissioners have not done stage wise geo-tagging to the completed public toilets.

Therefore, the Municipal Commissioners of Pitapuram and Ramachandrapuram

ULBs are requested to geo-tag the stage wise completed Public toilets and update the information in SAC website in order to release the balance funds.
