In references 1st ,2nd & 3rd cited, the Municipal Commissioners of Ponnur, Mydukur and Ramachandrapuram Municipalities have stated that the Swachh Andhra Corporation has sanctioned Public Toilets and sanctioned PTs were completed and requested to release the amounts of Rs.4.52 lakhs, Rs.2.60 lakhs and Rs. 1.90 lakhs respectively.

In the references 4th ,5th and 6th cited, the Swachha Andhra Corporation was accorded administrative sanctions for an amount of Rs.4.52 lakhs, Rs.2.60 lakhs and Rs.4.52 lakhs to the Ponnur, Mydukur and Ramachandrapuram Municipalities with 2 seats & 8 urinals, 2 seats & 2 urinals and 2 seats & 8 urinals respectively and an amount of Rs.2.26 lakhs was already released to Ramachandrapuram Municipality.

The above Municipal Commissioners are also request to submit the UCs for already released funds from the SAC to the undersigned with in the 15 days with out fail.
