Attention is invited to the subject and reference cited.

In the reference 1<sup>st</sup> cited, the Municipal Commissioner of Eluru Municipal Corporation has informed that the construction of 19 Community Toilets with 40 seats were completed in all aspects and put in use. Therefore, the Municipal Commissioner of Eluru Municipal Corporation has requested to release the balance 50% of the funds to make payments to the contractors.

In the reference 2<sup>nd</sup> cited, the SAC has accorded administrative sanctions for construction of 19 Community Toilets with 40 seats @ Rs.98,000/- per seat for an amount of Rs.39.20 Lakhs in 19 locations in Eluru Municipal Corporation and released 50% of the amount i.e Rs.19.60 lakhs to the Commissioner, Eluru Municipal Corporation vide cheque no.000042 on dt: 03.05.2018 through ICICI Bank.

On verification of the Swachha Andhra Corporation website, the Municipal Commissioner has not done stage wise geotagging of all the completed 19 community toilets.

In view of the above, the Municipal Commissioner of Eluru Municipal Corporation is requested to complete the stage wise geo-tagging to all the 19 sanctioned & completed Community Toilets and update the information in the SAC website, then only the balance 50% of the funds will be released to the ULB.

Further, it is also requested the Municipal Commissioner to submit the UCs for already released funds from the SAC to the undersigned with in the 15 days with out fail.
