In the reference first read above the Government permitted Swachha Andhra Corporation to release the amounts to the ULBs as per the Annexure – I to procure the Push carts under SBM SWM funds to handle Municipal Solid Waste efficiently.

Accordingly SAC has released the funds to the ULBs as indicated in the Annexure-I attached vide reference 2nd cited @ Rs.12,000/- per Pushcart and also to Nellore Municipal

Corporation , Venkatagiri Municipality & Sri Kalahasthi Municipality vide reference 3rd to 5th cited above. But many of the Commissioners are submitting that the amount of Rs. 12000/- is insufficient . But in Sl.No.237 in GOs & Circulars in SAC Website placed the specifications for Pushcarts and also quotation for Rs. 11650/- per Pushcart submitted by Smart Waste Management Solutions.

Hence the Commissioners of all ULBs who are yet to procure the Pushcarts are requested to go through the specifications and quotation placed in Sl.No.237 in GOs & Circulars in SAC Website and also invite Smart Waste Management Solutions to participate in the tenders for procurement of Pushcarts within Rs.12,000/- per Pushcart. All the ULBs are also requested to submit the status of procurement of Pushcarts in the prescribed proforma in Annexure-II enclosed.
