In the reference 2<sup>nd</sup> read above, the Commissioner, Jammalamadugu NP requested to sanction an amount of Rs. 41.78 lakhs towards 6 CTs with 18 seats for men and 18 seats for women and 1 PT with 3 seats & 3 urinals for men and 3 seats& 2 urinals for women.

In this regard it is to submit that an amount of Rs. 3.25 lakhs was sanctioned and released vide reference 1<sup>st</sup> cited towards construction of 1 CT with 5 seats at Rs. 65000/- per seat and UC is submitted for Rs. 3.08 lakhs. The details of CT were not uploaded in the SAC & SBM website.

Hence sanction is accorded to release an amount of Rs. 41.78 lakhs vide reference 3<sup>rd</sup> cited towards 6 CTs with 18 seats for men and 18 seats for women and 1 PT with 3 seats & 3 urinals for men and 2 seats & 2 urinals for women as mentioned in the reference 2<sup>nd</sup> cited above @ Rs. 98000/- per CT/PT seat and Rs. 32000/- per urinal and the same was released to the Commissioner Jammalamadugu NP vide Cheque No. 000083 through Andhra bank Dt. 15-11-2017. Hence the commissioner Jammalamadugu NP is requested to utilize the amount and submit the UC to this office duly

uploading the photos of all CTs&PTs in both SAC & SBM website.
