The Commissioner, Punganur Municipality vide reference 1st cited submitted that the Municipal Chairperson along with the Commissioner taken a mass campaign in the town for awareness of public on usage of twin bin system. Some organizations i.e. Rotary & Lions Club members and the walkers suggested to provide tilted bins at junctions and bus stand areas for removal of waste on war basis. But as the Municipality have no funds the Commissioner requested to sanction an amount of Rs. 6.00 Lakhs to procure 100 Nos. twin bins (200 Nos. bins).

Further the Commissioner, Punganur Municipality vide reference 2nd cited submitted that the Municipality requires compactor bins to collect and transport garbage through Compactor. As the financial position of the municipality is not sound requested to sanction an amount of Rs. 25.92 lakhs to procure 72 Nos. Compactor Bins.

So as per the request of the Commissioner, Punganur Municipality and subject to availability of funds under eligibility funds to Punganur municipality the following

are sanctioned.

1. An amount of Rs. 3.00 Lakhs towards procurement of 50 Nos. Twin Bins.
2. An amount of Rs. 8.64 Lakhs towards procurement of 24 Nos. 1100 L Compactor Bins.

Hence the Commissioner , Punganur Municipality is requested to procure the above as per the rules in vogue in order to maintain sanitation in Punganur Municipality and report compliance.
