The Commissioner , Srikakulam Municipal Corporation vide reference cited above submitted the corporation received 3 Nos. 14 cum RCVs and 5 Nos. 6 cum RCVs to which needed 70 Nos. compactor bins to main roads as the corporation is generating 70 MTPD which is to be transported to compost yard at andemvalasa situated at a distance of 10 km from the town.

Further submitted that Rs. 40.00 lakhs sanctioned towards approach road to the existing compost yard vide reference 2nd cited will be met from the funds of PUIAML of the urban infra structure projects and requested to sanction an amount of Rs.26.00 lakhs to procure Compactor bins.

It is to inform that an amount of Rs.9.00 Lakhs was sanctioned and released to SMC towards procurement of 30 Nos. 1100 L capacity compactor bins vide reference 3rd cited above.

Hence as per the request of the Commissioner , Srikakulam Municipal Corporation the work "Providing Approach road to the existing Compost Yard in Srikakulam Municipal Corporation" sanctioned for Rs.40.00 lakhs vide reference 2nd cited above is cancelled and to procure balance 40 No. 1100 L capacity Compactor bins in amount of Rs.16.00 Lakhs was sanctioned.

Hence the Commissioner, Srikakulam Municipal Corporation is requested to procure the above as per the rules in vogue in order to maintain sanitation in commercial areas only in Srikakulam Municipal Corporation and report compliance for fund releases.
