

Another 1 No. 6 cum capacity RCV may be re-deployed to Yemmiganur Municipality as per ED SAC instructions to the commissioner Yemmiganur Municipality to transport the garbage from Yemmiganur Municipality to Adoni Municipality compost yard for Bio-methanization plant.

Hence the Commissioner, Tadipatri Municipality is requested to send the 1 No. 14 cum capacity RCV to Anantapur Municipal Corporation and 1 No. 6 cum capacity RCV to Puttaparthi NP. Another 1 No. 6 cum capacity RCV to Yemmiganur Municipality.
