Your immediate attention is invited to the subject and reference cited, where in the JS & MD, SBM, has informed that it is indeed heartening to see the enthusiasm with which cities are now stepping up their efforts to declare themselves ODF and also get themselves certified as ODF through third party. We hope that in the coming months, more cities will be joining the fray in the race to become ODF and sustain their ODF status.

Going forward, we would like to strengthen the ODF protocol and declaration process, to increase their credibility and transparency. Accordingly, in addition to the existing conditions required to be met for ODF declaration, two more conditions will be required to be fulfilled for ODE declaration, viz.

A. Details of all Individual household toilets (IHHL) constructed from 2011 onwards will have to mandatorily be uploaded on the SBM-Urban portal.

B. Pictures of all functional community and public toilets in the city, irrespective of the date of construction, will have to mandatorily be uploaded on the SBM-Urban portal.

To summarise, the revised necessary infrastructure and regulatory conditions to be achieved before declaring a city/ ward as Open Defecation Free are as follows:

1) All households that have space to construct toilet, have

constructed one.

2) All occupants of those households that do not have space to construct toilet have access to a community toilet within a distance of 500 meters.

3) All commercial areas have public toilets within a distance of 1 kilometer.

4) Details of all Individual household toilets (IHHL) constructed from 2011 onwards will have to mandatorily be uploaded on the SBM-Urban portal

5) Pictures of all functional community and public toilets in the city, irrespective of the date of construction, will have to mandatorily be uploaded on the SBM-Urban portal.

This amendment will come into force with immediate effect, with intimation to the third party inspection agency too.

Therefore, I request that to follow the instructions in amendment to protocol for declaration of ODF in next round of swachh survekshan.
