Sub:- SAC-MA&UD Dept – FSTP projects – Piduguralla ULB – Clearing of dum from the site allotted for establishment of FSTP project in Piduguralla ULB – Permission accorded for release of funds from the available funds of SAC which was already released to the Municipal Commissioner, Piduguralla – Orders issued.

In the reference 2nd cited, SAC has accorded administrative sanction to Piduguralla Municipality for an amount of Rs.11.50 lakhs to provide infrastructure facility in site allotted for establishment of FSTP project and also informed that the sanctioned amount will be released only after completion the work . The details are as follows:

In reference 1st cited, the Municipal Commissioner of Piduguralla Municipality has informed that the debris clearance work was completed duly following the procedure and prepared bill for an amount of Rs.5.00 lakhs.

Further, the Commissioner has also informed that an amount of Rs.86.00 lakhs was released to Piduguralla Municipality for infrastructure development under SWM project through T.O.Proc.No.SAC/COO/F.No.78, dt: 03.02.2018. Out of which Rs.60.00 lakhs value of works was completed and an amount of Rs.14.00 lakhs works are in progress. The Municipality is having the available balance amount of Rs.12.00 lakhs under the head WtC infrastructure works.

Finally, the Municipal Commissioner, Piduguralla Municipality has requested to permit the Municipality to meet and pay an amount of Rs.5.00 lakhs from the balance funds available under WtC head. The Commissioner also request to release an amount of Rs.11.50 lakhs so as to meet the further expenditure under the head and reimburse the amount now proposed to pay.

ORDER:

In view of the above and after careful examination of the request made by the Municipal Commissioner, Piduguralla, permission is hereby accorded to meet the expenditure incurred for Rs. 5.00 lakhs for clearing of debris from the allotted site for establishment of FSTP project in Piduguralla ULB with the available funds of 12.00 lakhs under SWM funds.

The release of funds for Rs. 11.50 lakhs sanctioned from this office for providing infrastructure works in the site allotted for establishment of FSTP project will be given after submission of UCs for Rs. 86.00 lakhs which was already released to the Municipal Commissioner, Piduguralla for various infrastructure works under SWM funds.

The Municipal Commissioner, Piduguralla is requested to send Utilisation Certificates for Rs 86.00 lakhs which was sanctioned from this office for providing infrastructure works to the Waste to Compost project in Pidugurlla ULB at the earliest.

The sanctioned amount is chargeable to the Head of Account 2217-80-191-06-88-310-312 & 2217-80-191-12-88-310-312 from the SWM funds sanctioned by the Government.

Sanction is in accordance with rules.
