- d. Coconut Shredder – Rs.8.00 Lakhs
- e. Trammel Screener – Rs.5.00 Lakhs
- f. Tractor Mounted Windrow Turner _ Rs.10.00 Lakhs
- g. 9 Ltrs. Dust bins for DtD collection – Rs.24.00 Lakhs
- h. Twin Bin system in Commercial areas – Rs.2.00 Lakhs
- i. New Cages – Rs. 2.50 Lakhs
- j. Pillar Boards – Rs.1.50 Lakhs
