The Commissioner, Nellore municipal Corporation vide reference 1st cited above submitted that as the Hon'ble Minister , MA&UD instructed to distribute the HH Bins to all the House Holds in Nellore Municipal Corporation estimate was prepared by NMC to an amount of Rs.100.47 Lakhs to supply bins to remaining 1,20,000 HHs and requested to accord administrative sanction for the procurement of above said bins and to release necessary funds to take up the above said work.

In this regard it is submitted that the funds released under SBM - SWM component for the Mission period 2014-2019 were completely exhausted and also the NMC has utilized their eligibility funds completely under SBM-SWM component and sanction may be accorded to the procurement of HHs Bins to 1,20,000 HHs in Nellore Municipal Corporation to an amount of Rs.100.47 Lakhs subject to funds allocation in the next year Budget under SWM.

Accordingly the government has approved the same vide reference 2nd cited above.

As per approval vide reference 2nd cited the administrative sanction was accorded for procurement of House Holds Bins to 1,20,000 HHs in

Nellore Municipal Corporation to an amount of Rs.100.47 Lakhs subject to funds allocation in the next year Budget under SWM.
