The Commissioner , Addanki Nagara Panchayat vide reference cited above submitted that land to an extent of 4.0 Acres was alienated for construction of FSTP and Waste to Compost Plant in Addanki Nagara Panchayat. The Agencies who were entrusted the above works visited the site and informed that the work will be taken up only after the site is levelled as the site is with gravel quarried pits of 5 to 8 feet depth and uneven hill area.

Further submitted that the Executive Director , SAC has inspected the site and issued instructions to the Commissioner, Addanki Nagara Panchayat to submit the proposals for levelling and fencing to the land area. Accordingly the Commissioner, Addanki Nagara Panchayat submitted estimated proposal to an amount of Rs.34.15 Lakhs towards providing fencing including levelling the site proposed for Waste to Compost Plant and FSTP and requested to sanction the amount under SBM funds.

As per instructions of ED,SAC and request from the Commissioner, Addanki Nagara Panchayat an amount of Rs.34.15 Lakhs be sanctioned to take up the Waste to Compost Plant and FSTP under SWM funds.

In view of above hereby accorded sanction to an amount Rs.34.15Lakhs ( Rupees Thirty Four Lakhs and Fifteen Thousands only )towards the work “ Providing fencing including levelling to the site proposed for Waste to Compost Plant and FSTP in , Addanki Nagara Panchayat” and to release the same to the Commissioner , Addanki Nagara Panchayat.
