In the reference 2nd cited, the Managing Director, Swachh Andhra Corporation, Vijayawada was accorded administrative sanctions for an amount of Rs.7.16 lakhs for construction of one Public Toilet with 6 seats and 4 urinals near East peta Municipal Primary School in Punganur Municipality and released an amount of Rs.3.58 lakhs at the time of according Administrative Sanction. The Managing Director, Swachh Andhra Corporation was directed the Municipal Commissioner, Punganur Municipality to complete the sanctioned the public toilet in order to release the balance 50% amount.

In the reference 1st cited, the Municipal Commissioner, Punganur Municipality has reported that the sanctioned public toilet at East peta Municipal Primary School has been completed and same was geo-tagged in Swachh Andhra Corporation website in ward No.7. Therefore, the Municipal Commissioner of Punganur Municipality has requested to release the balance 50% amount of Rs.3.58 lakhs towards payment of completed public toilet.

ORDER:

After careful examination of the proposals submitted by the Municipal Commissioner of Punganur Municipality, Sanction is hereby accorded to release the balance 50% amount of Rs. 3,58,000/- (Rupees Three Lakhs and Fifty Eight Thousand only) to the Municipal Commissioner of Punganur Municipality towards payment of completed Public Toilet at East peta municipal primary school.

The Municipal Commissioner of Punganur Municipality is directed to send the details of the M.Book, Work completion certificate and particulars of Contractor for payment of bills through CFMS Green Channel Account directly from the Swachh Andhra Corporation, Vijayawada.

The expenditure shall be met from the available funds under CTs/PTs Head of Account 2217-80-191-06-87-310-312 & 2217-80-191-12-87-310-312 of SBM Urban Budget.
