ORDER:

The Government of India have taken up the Swachh Bharat Mission with a view to make all Indian Cities and towns totally sanitized, healthy and livable to derive Public Health and Environmental outcomes for all citizens with special focus on hygienic and affordable sanitation for the urban poor and women. The main mission objective is elimination of open defecation, 100% collection and scientific procession, disposal, re-use and recycling of Municipal Solid Waste, creating an enabling environment for private sector participation in Capital and O&M expenditure, IEC and Public Awareness.

2. In order to implement the component under Swachh Bharat Mission in Urban Areas in the State of Andhra Pradesh, Government considered necessary to establish a Swachh Andhra Corporation to carry out the activities including Individual Sanitary Latrine Scheme (ISLS) and Solid Waste Management etc., in the State of Andhra Pradesh.

3. Government after careful examination of the matter, have decided for establishment of Swachh Andhra Corporation for effective implementation of the components of Swachh Bharat Mission in Urban Local Bodies in Andhra Pradesh including the activities of Individual Sanitary Latrine Scheme and Solid Waste Management.

4. An amount of Rs.150.00 Crores (Rupees One hundred and fifty Crores only) is sanctioned as seed capital for the Swachh Andhra Corporation, from the Consolidated fund of Andhra Pradesh, for carrying out the activities of Individual Sanitary Latrine Scheme (ISLS) and Solid Waste Management etc.

5. The Commissioner & Director of Municipal Administration, A.P., Hyderabad/the Managing Director, Andhra Pradesh Urban Finance and Infrastructure Development Corporation, A.P., Hyderabad shall take necessary action in the matter accordingly.

6. This order issues with the concurrence of Finance Department vide their No.694/PFS/15, dated 12.02.2015.
