ORDER:

In the G.O 1st read above, the Finance Department have issued Budget Release Order for an amount of Rs.100.00 crores to the Managing Director, Swachha Andhra Corporation during the financial year 2014-15. Accordingly, administrative sanction orders were issued vide G.O. 2nd read above.

2. The financial assistance for the scheme by the Government of India and the Government of Andhra Pradesh for construction of units will be as follows:

2.	Community Toilets (per seat)	65,000	GoI - 26,000 GoAP- 39,000
3.	Public Toilets	100%	Private funding

3. In the reference 3rd read above, the Commissioner & Director of Municipal Administration, A.P.Hyderabad has furnished proposals for the amounts required for construction of Individual Sanitary Toilets and Community Toilets and the amounts now proposed to be released.

4. Government after careful examination of the proposal of the Commissioner & Director of Municipal Administration, A.P. Hyderabad in the reference 3rd read above, hereby distribute an amount of Rs.69.00 crores (Rupees Sixty nine crores only) towards the State Share to various ULBs for utilization of the amount for construction of individual household toilets and community toilets in ULBs as detailed in the Annexure-A and B to this order.

5. The implementation guidelines for construction of Individual Household Toilets, Community Toilets and Public Toilets are issued in Government Memo.No.172/B2/2015-3, Dt.20-3-2015, for compliance.
