ORDER:-

In the reference 1st read above, the Commissioner, Kurnool Municipal Corporation, Kurnool has reported that the Municipal Corporation has resolved to handover necessary land to M/s. Nexus Novus Import and Distribution Pvt. Ltd., Bangalore, to lease the site to an extent of Ac.6.178 for a period of 25 years in Survey No. 751 and 180/2 of Gargeyapuram Village, Kurnool District, which is under the possession of Kurnool Municipal Corporation as per District Collector's Orders for setting up of waste to energy plant.

The Director of Municipal Administration, A.P., Guntur in his letter 2nd read above has requested the Government to issue necessary orders for lease out an extent of Ac.6.178 cents in Survey No.751 and 180/2 of Gargeyapuram Village, Kurnool District, for a period of 25 years for setting up of waste to energy plant as requested by the Commissioner, Kurnool Municipal Corporation, Kurnool.

3. After careful examination of the proposal and in-exercise of the powers under Rule 12(1)(h)(1) of A.P. Municipalities (Regulation of Receipts and Expenditure) Rules,1968 read with G.O.Ms.No.56, MA&UD(J1) Department, dated.05-02-2011, Government hereby permit the Commissioner, Kurnool Municipal Corporation, Kurnool to lease out the land to an extent of Ac.6.178 cents in Survey No.751 and 180/2 of Gargeyapuram Village, Kurnool District to M/s.Nexus Novus Import and Distribution Pvt. Ltd., Bangalore for a period of 25 years for setting up of Waste to Energy Plant.
