ORDER:-

The Commissioner, Guntur Municipal Corporation, Guntur has reported that the Municipal Corporation has resolved to hand over necessary land to JITF Urban Infrastructure Limited, New Delhi, on lease for setting up of Waste to Energy Plant, that it is also proposed to lease the site to an extent of 20.00 Acres for a period of 25 years situated in R.S. 933, 938, 939, 943 of Kondaveedu Revenue Village of Edlapadu Mandal, Guntur District which is under the possession of Guntur Municipal Corporation as per District Collector's Orders.

2. The Director of Municipal Administration, AP, Hyderabad has reported that the Commissioner, Guntur Municipal Corporation, has submitted the lease proposal prepared based on the directions/guidelines issued by the Government in G.O. Ms No 56, MA, dated 05.02.2011, along with the details of lease values fixed and stated that the JITF Authorities have submitted the lease rent as per bid document for 20.00 Acres of Land.

3. The Director of Municipal Administration, A.P, Hyderabad has requested the Government to issue necessary orders for lease of an extent of Ac.20.00 in Survey Nos.933, 938, 939, and 943 of Kondaveedu Revenue Village of Edlapadu Mandal, Guntur District, and also to fix the lease amount on the site in accordance with the provisions at an early date to take necessary action.

4. Government after careful examination of the matter and in exercise the powers under rule 12(1)(h)(1) of A.P. Municipalities (Regulation of Receipts and expenditure) Rules,1968 read with G.O.Ms.No.56, MA&UD(J1) Department, dated 05-02-2011 hereby permit the Commissioner, Guntur Municipal Corporation, Guntur to lease out the land to an extent of 20.00 Acres situated in R.S.

933, 938, 939, 943 of Kondaveedu Revenue Village of Edlapadu Mandal, which is under the possession of Guntur Municipal Corporation for setting up of Waste to Energy Plant for a period of 25 years.

5. The Director of Municipal Administration, A.P.,Hyderabad/The Commissioner, Guntur Municipal Corporation, Guntur shall take further action in the matter.
