The Project Proposal submitted by you was considered Technical Evaluation Committee has evaluated your implementation plans of MSWM projects i.e. production of City Compost from Municipal Solid Waste and marketing the Compost in the open market while carrying out SLF of rejects as per MSW Rules – 2016.

Following this process, SAC on behalf of Yellamanchili ULB is pleased to inform you that M/s. KLK Chitra Sea Foods JV with M/s Hasper Solution and M/s Cube Bio Energy Pvt Ltd, has been selected as the “Successful Bidder” (as per the provisions of the RFP document) for **Development of Municipal Solid Waste Management (MSWM) Project in Yellamanchili** being lowest bid offered by you for Rs. 4000 per Ton of City Compost (organic manure) Sold.

This LOA i.e. award of work is subject to the terms and conditions set out in the RFP issued to your consortium and would further be subject to the conditions set out in the Concession Agreement to be executed by M/s. KLK Chitra Sea Foods. This ‘Letter of Award’ is based on the following conditions:

- M/s. KLK Chitra Sea Foods shall enter into a Tripartite Concession Agreement with the Yellamanchili ULB and Swachha Andhra Corporation at the earliest, detailing the Terms & Conditions of implementing and managing

**Municipal Solid Waste Management (MSWM) Project in Yellamanchili ULB through Design build-operate-transfer (DBOT) basis.**

- M/s. KLK Chitra Sea Foods shall furnish the Yellamanchili ULB a Performance Guarantee equal to Rs. 1,87,950/- (Rupees One Lakh Eighty Seven Thousand Nine Hundred and Fifty only) at the time of signing the Concession Agreement/Land lease Agreement or within 60 (sixty) days from the date of this Letter of Award, whichever is earlier. The cumulative Bid Security furnished by you for Rs. 5,00,000/- (Rupees Five Lakhs only) will be returned after submission of all Performance Guarantees to the ULBs as per your LOAs. The Performance Guarantee shall be retained by Yellamanchili ULB during the Concession period as indicated in the RFP.
- M/s. KLK Chitra Sea Foods shall be governed by the Terms and Conditions stated in the RFP and Concession Agreement. KLK Chitra Sea Foods shall not attach any condition on any of its obligations as stipulated in the RFP document and Concession Agreement; and
- M/s. KLK Chitra Sea Foods shall submit a detailed Project Implementation & Operation Plan in line with the Technical Proposal submitted along with Bid documents within 60 (sixty) days of issue of LoA for the Yellamanchili ULB approval. The project construction shall be completed and Commission within Six Months from the date of Handing over of Project Site.

This letter is awarded in duplicate. The duplicate copy of this letter may be signed and returned as a token of acceptance of the above terms & conditions.

This order is issued with the concurrence of Government of Andhra Pradesh vide orders 3<sup>rd</sup> cited above.
