Attention is invited to the subject and reference cited.

Vide reference cited, it is to inform that the regional review meeting held on 30.10.2018 at Chennai with MoDWS Officials. It was observed that there are some adverse implications in the key parameters (LOB, Geo tagging, Swachhagrahis & Shared toilets).

The quality of Swachhgrahis in Andhra Pradesh is termed as very low, GoI conducted an exercise by calling random swachhagrahis and the response is quite bad. Similar exercise has been taken up in our office and the results were no different. A total of 130 swachhagrahis @10 per district where only 40% (52) are swachhgrahis and even in that only 5% of the swachhgrahis of the total verified were paid(The details are enclosed).

Vide reference 2nd cited, all the districts were requested to delete the inactive swachhgrahis from D13 module of IMIS and the final list of Swachhgrahis. But none of the districts furnished the information.

In view of the above, it is requested to update the status of the Swachhagrahis to active or inactive through D13 Module of IMIS, In case of inactive swachhagrahis new swachhagrahis to be appointed and reported in IMIS through the same module.

Further, it was observed that LOB entries made by the districts are not according to the guidelines. Districts to conduct detailed survey of the newly entered beneficiaries and purify the information and replace the already made entries with genuine beneficiaries through J02 module of IMIS (The details are enclosed).

A total of 1,84,504 households are still accessing shared toilets in Andhra Pradesh. Specifically in the districts Ananthapur, Chittoor, Guntur, Kurnool, Srikakulam & Visakhapatnam even after the provision of LOB and sanction of CSCs. Districts to enter the HHs who are eligible for IHHL in J02

which are currently in shared toilets and all the Other HHs which are not having IHHLs to be tagged to CSCs in the village.

There are 5 districts where the geo tagging is not 100% even after declaration along with this there are around 80,069 IHHLs which are not approved by the districts till date. Districts to complete the balance geotagging and also approve the unapproved photographs through the district login by 25.11.2018(The details are enclosed).

Therefore, it is requested to issue necessary instructions to the concerned to take necessary action on the above issues and same may be resolved by 25.11.2018.

## **LOB – Left Out of Baseline**

- ➤ MoDWS, GOI has sanctioned toilets for **2,25,509 HHs** under LOB (Left Out Baseline) and accordingly district wise cap has been fixed based on their requirement.
- ➤ GOI has given Separate Data Entry Modules for reporting/approvals of LOB beneficiaries are designed and incorporated in the IMIS application as follows.
  - o **J01** District CAP for LOB by the State.
  - o J02 Entry of LOB beneficiaries by Districts.
  - o **J03** Approval of LOB entries by District/State.
  - o **J04** Entry of Physical & Financial progress of LOB.
  - o **J06** Approval of MPR (Physical & Financial) LOB by the State.
- Districts have entered 1, 55, 273 LOB entries in J02 Module as shown below.

- No more left out households in BLS 2012-13, no funds will be asked in future on this specific account.
- No Duplicate Entry and Duplicate payment is made in IMIS of SBM(G) for such LOB entries.
- LOB claimed by the District for funding under SBM(G) do not possess a functional toilet at present.
