Attention is invited to the subject and reference cited and please find the enclosed copy of the reference cited.

Vide reference 1st cited, the video conference was held by the Secretary, MoDWS on 05.12.2019 with ACS/Principal Secretary/Secretary and Mission Directors in-charge of Rural Sanitation in the States to discuss the progress of Left out Baseline (LOB) and No one Left Behind (NOLB) toilets constructions. During the VC the following instructions are issued by the Secretary, Ministry of Jal Shakti, GOI.

- I. Construction of LOB & NOLB toilets shall be completed duly following the below timelines.
 - a. LOB construction should be completed by 31st January'2020.
 - b. NOLB beneficiary details should be entered in IMIS by 31st December'2019.
 - c. NOLB construction should be completed by 15th February'2020.
- II. Due diligence should be done on geo-tagged toilets uploaded in IMIS.
- III. Ensure no gaps will be noticed either in construction or in usage of toilets during the ongoing 3rd round of NARSS (National Annual Rural Sanitation Survey)by GOI.

In this regard, it is to submit that already we have issued instructions to all the Districts (through ref 2nd cited) to ensure that no one should be left behind, and that if there is any eligible beneficiary who has been left out, the

concerned district authorities should ensure that this basic service is speedily provided. But the progress of LOB & NOLB construction is very slow.

Therefore, all the District Collectors are requested to bestow their personal attention and issue necessary instructions to the SE, RWS&S and Department Concerned to expedite the progress of LOB & NOLB in the stipulated timelines as directed by the Secretary, Ministry of Jal Shakthi, GOI.

Vide reference cited, Ministry of Jal Shakti Department of Drinking Water and Sanitation has informed that positive behavior change for adoption of safe sanitation practices as well as ensuring that no one is left behind, are key to achieve the goal of the Swachh Bharat Mission. In the last five years, tireless efforts have been made by village motivators, elected panchayat officials, community-based organizations and government officials to undertake behavior change communication to encourage rural households to stop defecating in the open and use toilets instead. This massive janandolan has led to an unprecedented change in the rural sanitation situation of the country. People from all walks of life have shown an exemplary commitment towards making India Open Defecation Free (ODF).

However, some recent media reports have been brought to the notice of MoDWS Department which are showing that certain forms of inappropriate actions, extreme coercive actions (particularly instance of Shivpuri district, Madhya Pradesh), are still being practiced. In this regard MoDWS Department has already issued advisory on 25th July, 2017 suggesting to avoid any coercive measures for ensuring construction and usage of toilets. It is reiterated that coercive action taken by anybody, including government or elected officials or private individuals with respect to sanitation behavior of any kind is totally unacceptable under any circumstance.

In such cases, the concerned authorities should prosecute the guilty to the fullest extent of the applicable law. It is also reiterated that Central and State Governments are fully committed to the achievement and sustaining of open defecation status across rural India. As per the advisories issued on 31st July, 2019 and 7th August, 2019, it is reiterated that no one should be left behind, and that if there is any eligible beneficiary who has been left out, the concerned State and district should ensure that this basic service is speedily provided.

In view of the above, it is to inform that above mentioned two letters i.e., 31st July, 2019 and 7th August, 2019 were communicated to all the District Collectors and requested to ensure that construction of CSCs in all the villages with predominant SC/ST habitations is taken up in a mission mode and is completed within the prescribed timeline i.e., 31st December 2019 and also requested to identify if any left out eligible rural households without toilet, and to accord sanction and also to complete all the IHHLs before the target date i.e., by 30th September 2019.

Therefore, once again it is requested to issue necessary instructions to concerned to ensure that no one should be left behind, and that if there is any eligible beneficiary who has been left out, the concerned district authorities should ensure that this basic service is speedily provided.



This massive janandolan has led to an unprecedented change in the rural sanitation situation of the country. However, some recent media reports have been brought to the notice of this Department which are showing that certain forms of inappropriate actions, extreme coercive actions (particularly instance of Shivpuri district, Madhya Pradesh), are still being practiced. Dear Principal Secretary/Secretary,



Subject:- Special drive to achieve universal sanitation coverage and elimination of open defecation in rural areas

Madam/Sir,


Swachh Bharat Mission (Gramin) [SBM(G)] was launched with the aim to achieve universal sanitation coverage by 2nd October, 2019. The States/Union Territories have made noticeable efforts towards achieving this goal and as a result, sanitation coverage as reported in IMIS of SBM(G) has increased from 39% at the time of start of the programme in 2014 to over 99% as on date.

2. As we move closer to 2nd October, the States must make special efforts to reconfirm universal sanitation coverage, and must identify if there are still any eligible rural households (as per the SBM-G guidelines) that may still have been missed out, and must cover them with individual household toilets under the programme.

3. In this regard, States like Punjab and Bihar have issued public notices to invite any households that may have been missed out of SBM(G)'s baseline survey, to build their toilets and receive the incentive amount within a stipulated time. Public Notices issued by Punjab and Bihar are enclosed at **Annexure-I** for reference. Such efforts have been found to be effective in reaching out to missed out households, if any, and support them to realize access to safe sanitation.

4. In view of the above, you may consider adopting similar practices to reach out to the households without toilets and support them in having household toilets built by **30th September, 2019**. The guidelines in this regard are enclosed at **Annexure-II** for reference, which are indicative and the States/UTs may adopt the same with suitable changes, if required.

Subject: Construction of community toilets in villages with predominant SC/ST Habitations by 31st December 2019

Madam/Sir

Swachh Bharat Mission (Gramin) was launched with the aim to achieve universal sanitation coverage by providing access to toilets to all the rural households and to ensure sustainability of its outcome through intense behaviour change campaign. SBM(G) guidelines also emphasize on the significance of equity and inclusion and provide for prioritizing construction of toilets for socially and economically marginalized people and to provide toilets with standard design for households living in areas where it is difficult to construct simple toilets due to high water tables, sandy soils or hard rock etc.

2. As SBM(G) is heading towards its deadline, it is important that special efforts be made in the last leg of the Mission to ensure access to toilets for all especially for the socially and economically marginalised households and for those households who are residing in difficult terrain.

3. In view of above, it has been felt that construction of Community Sanitation Complexes in the villages having habitations with predominant SC/ST population is one of the key factors for ensuring universal sanitation coverage and sustainability of ODF status in such villages.

4. Thus, Community Sanitary Complexes may be constructed in all such villages with appropriate no. of toilet seats and bathing space, if required. For construction of Community Sanitary Complexes in the villages, the States may use handbook for establishment of CSC issued by this Department which is available on the SBM(G) website (URL for the hand book is as follows: <https://swachhbharatmission.gov.in/sbmcms/writereaddata/images/pdf/technical-notes-manuals/Community-Sanitary-Complex.pdf>). In this regard, reference is also invited to this Department's letter of even no. dated 09.08.2016 regarding making provision for accessibility for persons with disabilities in all CSCs constructed under SBM(G). Accordingly, at least one of the toilet seats in these CSCs must be made *Divyang* friendly and should have easy access for *Divyang* people.



5. Further, it is reiterated that as per SBM(G) guidelines financial assistance of upto Rs. 2 lakhs in the ratio of 60:30:10 can be provided for construction of a CSC. However, the State have the flexibility to meet the additional requirement, if any, from their own funds or from other sources of funds such as 14th FC, CSR etc. Besides, the States can use the existing World Bank Performance Grant to achieve saturation of SC/ST habitations with community toilets as per the prescribed cost norms of SBM(G) guidelines. Operation and maintenance of these CSCs is the responsibility of the Gram Panchayat and they have to ensure its proper maintenance and cleanliness to ensure sustainable use of such CSCs by the community.

6. Construction of CSCs in all the villages with predominant SC/ST habitations may be taken in a mission mode and has to be completed by 31st December 2019. A rapid appraisal may be undertaken to identify SC/ST habitations that need a community toilet. A committee of people from SC/ST habitation that need a community toilet, may be constituted to supervise construction and maintenance of the toilet complexes. This committee should also ensure construction of the toilet complex within the prescribed time limit. However, for ease of maintenance, an individual/Group from the same village where the community toilet is constructed should be made responsible for daily operation and maintenance under the overall supervision and support of Gram Panchayat.

7. You are, therefore, requested to issue appropriate direction to the concern authorities to ensure that construction of CSCs in all the villages with predominant SC/ST habitations is taken up in a mission mode and is completed within the prescribed timeline.
