Attention is invited to the subject and reference cited.

Vide reference cited, the Registrar of High Court of Judicature has requested to issue necessary instructions to the concerned to undertake construction of toilets for litigant public in all the court complexes on priority basis.

In this regard, administrative sanction is hereby accorded in 60:30:10 ratio (90% from SBM(G) share & 10% from GP share) for an amount of Rs. 64.00 lakhs for construction of 32 CSCs (@2.00 Lakhs per each unit) near court premises in rural areas. The district wise list of CSC are as follows:

Further it is to inform that as per SBM guidelines, the Community Sanitary Complexes comprising an appropriate number of toilet seats, bathing cubicles, washing platforms, Washbasins etc, can be set up in a place in the village acceptable and accessible to all.

The maintenance of such Complexes is very essential for which Gram Panchayat should own the responsibility and the Operation and Maintenance should be assured for user families. It is also requested to tag the beneficiaries in IMIS site under CSC category.

Therefore, it is requested to issue necessary instructions to the concerned to identify the executing agency and entrust the work of construction of the CSCs near court premises as per the list attached. The plan and elevation drawings are herewith attached for reference. Also the detailed procedure for uploading the CSCs by geo-tagging can be downloaded from our website from Sl.No.90 under Gramin head. Unless the geo-tagging is done payments cannot be released.

I am to invite your attention to the letter 2<sup>nd</sup> cited of the Secretary to Government, Law Department forwarding therewith your letter 1<sup>st</sup> cited, and to state that the Hon'ble High Court accepted your proposal for construction of toilets for litigant public in all the Court Complexes in the State of Andhra Pradesh with your funds, and accordingly, the Registry has addressed letter dated 16-08-2018 to all the District Judges requesting to provide adequate space in all the Court Complexes, a copy of which was marked to you.

In this connection, I am to state that the Registry of the High Court has called for information from all the District Courts in the State as to availability of space for construction of toilets for litigant public and the said information is enclosed in Annexure-A to this letter.
