Attention is invited to the subject and reference cited.

The verification of ODF declared villages is taken up through empaneled agencies identified by MoDWS, GoI. Already **7902 villages were verified successfully. Now 8485 villages have been distributed among 3 agencies.** The details are indicated in the annexure attached to the letter.

The agencies are starting the verification work immediately and they have been instructed to meet the SEs RWS&S concerned and proceed with verification work. The agencies have been requested to submit their staff details along with phone numbers who are attending the verification work. Soon after receipt of the list from them the same will communicated to all districts.

Further, it is requested to provide the logistics & transportation arrangements by the District administration at mandal HQ's to the agencies as per NLM guidelines. The expenditure towards agencies will be paid by SAC, Vijayawada under IEC component of SBM (G) funds up on the submission of original bills to this office. No need to pay any amount by the District to agencies during the verification process.

Therefore, it is requested to issue necessary instructions to CEOs ZP, SEs RWS, and also to all the concerned village level authorities to coordinate with the agencies as and when they come to the districts and visiting the villages for attending their verification work.
