Attention is invited to the subject and reference cited.

You are aware, the State of Andhra Pradesh has achieved the ODF status in record time with the efforts made by all the District Collectors and their team. The Hon'ble Chie Minister desired to achieve ODF-Sustainability by 2<sup>d</sup> October, 2018 and ODF+ by the end on December, 2018, and requested to extend the same spirit and commitment to achieve the goal.

To achieve this, the Swachh Andhra Corporation, has developed a web application and placed it in RWS log-inwww.sbm.ap.gov.in, for entry of basic data of GP by all MPDOs. The same was communicated to all the districts through mail dt.22/6/2018.

The modalities have been prepared for procurement of infrastructure like Tri-cycles, power autos, Tractors, Bins, Incinerators, Shredders etc., by issuing a G.O.75 and the same was communicated through letter on 24/6/2018 and the same was placed in SAC website in SI.No.124 under gramin head.

For geo-tagging of asset through mobile app 1.0.7 and for release of payments to the agencies on procurement of above materials a payment gate way was developed and the same was communicated through letter on 11/7/2018 along with user manual and the same was placed in SAC website in SI.No.131 under gramin head.

The circular instructions on SLWM activities for procurement of machinery along with specifications and necessary GOs is communicated to all the districts on 12/7/2018 and the same was placed in SAC website in SI.No.133 under gramin head.

The circular instructions on ODF-S and to conduct training programme for masons on ODF-S along with training material and to conduct training programme to all Green Ambassador & Panchayat Secretaries on SLWM activities along with training material is communicated to all the districts on 12/7/2018 and the same was placed in SAC website in Sl.No.134 under gramin head.

Log-in credentials for EoPRD and DPO in payment gateway for approval sake are

communicated to district through mail and the same placed in SAC website in Sl.No.138 unde gramin head.

Necessary modifications have been made to the existing user manual for GP wise assests creation and payment module was communicated through mail and also the same is placed in SAC website in SI.No.140 under gramin head.

Totally, 15830 CSCs were sanctioned to the districts near AWCs, Schools and to the households in GPs with different unit costs. The grounding of CSCs is not satisfactory. The distric wise progress is enclosed and letter is placed in SAC website in Sl.No.129 under gramin head Necessary steps may be taken for the grounding and early completion of the same.

Further, it is to inform that certain amounts were released to the districts under IEC component to meet the expenditure of all SBM (G) activities. But, it is noticed that the expenditure details are not up-dated in IMIS site. This may be reviewed.

It is also to inform that recently the MoDWS, GoI has launched "Swachh Surveksha Gramin-2018" taking up the evaluation process by an Independent Agency named as "KANTA PUBLIC" to rank districts and States of India on the basis of quantitative and qualitative valuation in a village. The District Collectors may take up this as priority item. The letter, brochure and training material, and soG copies of material for bill boards, posters and wall paintings is sent to all districts and the same is placed in SAC website in SL.Nos. 136, 144 & 145.

Therefore, once again the District Collectors are requested to bestow their persona attention on the above issues and issue necessary instructions to the concerned CEO, DPO & SE RWS to achieve ODF+ status before the targeted date.
